With the enactment of The American Jobs Creation Act of 2004, Registered Investment Companies are now able to exempt from withholding the qualified interest income dividends paid to foreign investors. Of the net investment income dividends paid above, 89.10% of the Diversified Bond Fund dividends, 79.91% of the Multistrategy Bond Fund dividends, and 89.14% of the Short Duration Bond Fund dividends are exempt from the U.S. withholding tax.
