With the enactment of The American Jobs Creation Act of 2004, Registered Investment Companies are now able to exempt from withholding the qualified interest income dividends paid to foreign investors. Of the net investment income dividends paid above 91.74% of the Diversified Bond Fund dividends and 77.59% of the Multistrategy Bond Fund dividends are exempt from the U.S. withholding tax.
